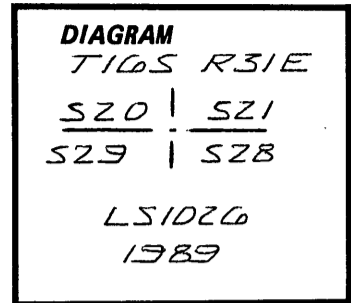


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Original corner established by Samuel W. Lackland, deputy surveyor, under G.L.O. contract No. 357 dated July 2, 1880 and performed that year. Surveyor general's record states: North between Sections 28 and 29. Va. 18°30' East.



- 79.00 Enter marsh.
- 80.00 Set post for corner to Sections 20, 21,28 and 29 with pits and mound as per instructions.

Description of corner evidence found:

At assumed corner location found Chalk stone 18"x18"x3" lying flat alongside old fence corner North (now down)-East-West-South (now down). Stone marked with 2 vertical grooves, letters "C S" and numerals "1962" on down face and 4 grooves East edge. Old survey lath was nailed to fence corner post. Local land owners have accepted this location as the section corner for many years. I believe this corner probably monumented by Vernon Glaze, Grant County Surveyor, 1914-1921, some of whose records have been lost. He remonumented a number of such corners in this area of Bear Valley at that time.

Description of monument and accessories | established to perpetuate the original location of this corner:

At position of marked stone set a 2-1/2"O.D.x30" long aluminum pipe 24" in ground with a 2-1/2" diameter aluminum cap marked as shown: Deposited stone East alongside cap.

RM's Set:

A 1"x24" long iron rod bears North 49-1/2° East, 26.77 ft., stamped "RM S21 LS1026 1989"; a 1"x24" long iron rod bears South 17-1/2° East, 24.86 ft., stamped "RM S28 LS1026 1989"; a 1"x24" long iron rod bears South 82-3/4° West, 27.22 ft., stamped "RM S29 LS1026 1989"; a 1"x24" long iron rod bears North 64° West, 21.28 ft., stamped "RM S20 LS1026 1989". Set steel post 1 ft. from RM on line from cap extended with sign 54-3 and 54-9. Set steel post 5 ft. North with sign 54-9 facing cap.

I hereby certify that the above corner monument was re-established as herein described on November 8, 1989.
